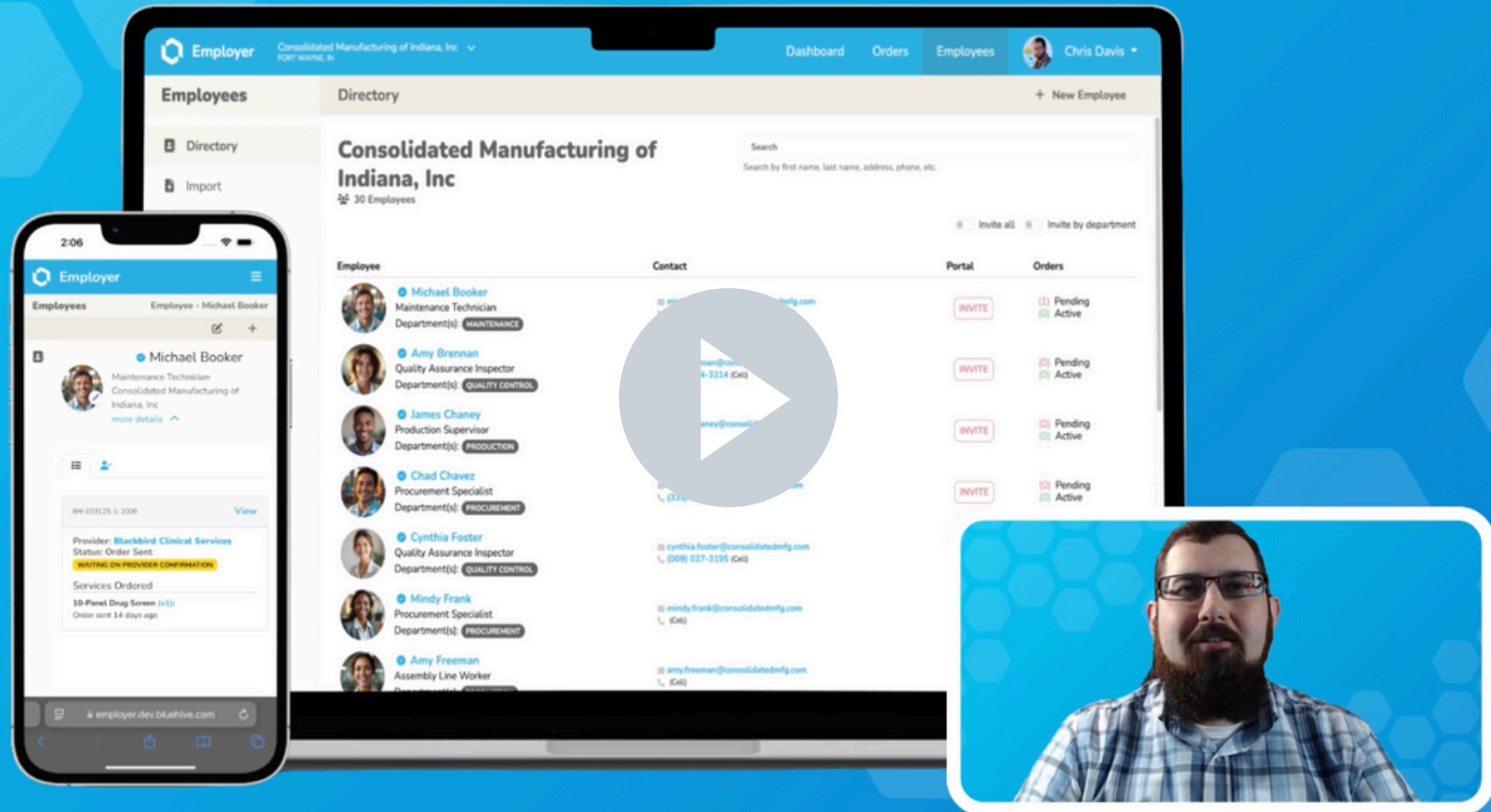

-  **May 1, 2025 (Thursday):**
 - Start of Mental Health Awareness Month - Emphasize wellness initiatives in the workplace.
 - Reminder to post Q1 401(k) plan notices or benefit statements.
 - [OSHA Form 300A](#) can be taken down.
-  **May 15, 2025 (Thursday):**
 - Deadline for filing [Form 990](#) (Return of Organization Exempt from Income Tax) for non-profits operating on the calendar year.
-  **May 31, 2025 (Saturday):**
 - Deadline to complete workplace safety audits and ensure OSHA logs are updated for Q2.

Compliance and Work Observances



June 15, 2025 (Sunday):

- Q2 Payments: Self-employed individuals and small business owners must file [Form 1040-ES](#) for income earned April 1–May 31.
- Foreign Filers: U.S. citizens abroad and certain foreign entities may also have tax or estimated payment deadlines, unless extended.



June 30, 2025 (Monday):

- [EEO-1 Reporting](#) (if applicable): Confirm submission if required for employers with over 100 employees or federal contractors.

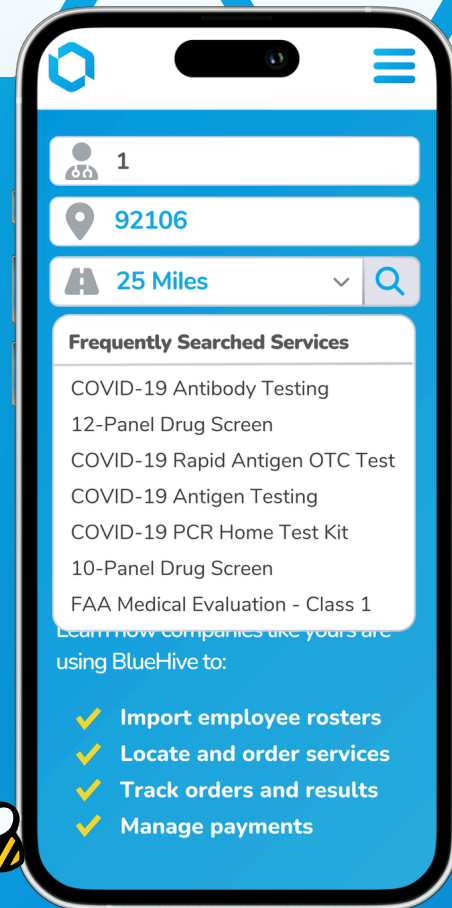

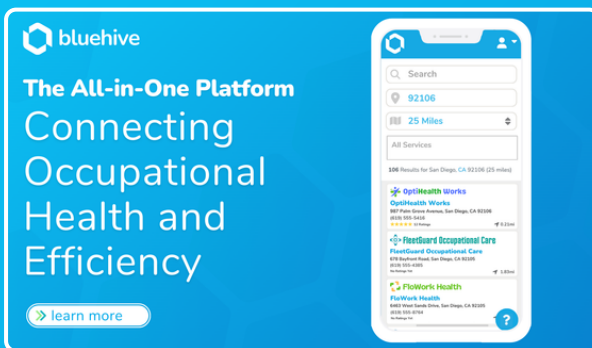

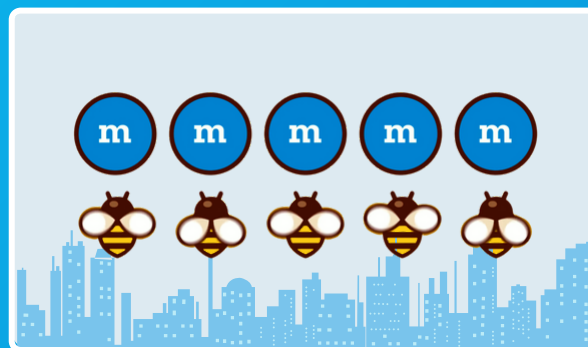
